Commercial Bids – Group Personal Accident policy (BFSL employees)

The Financial Proposal should be submitted in the form of one hard copy which should be placed in a sealed envelope super-scribed as “Commercial Bid”

The commercial should contain the bid including the professional fee and out of pocket expenses will be paid by BFSL.
