1	This is a non exclusive fixed fee monthly contract which will be likely to
	continue unless /until company deemed to continue it .It is not a mutually
	exclusive on the part of vendor, company holds the right to cancel the contract
2	Buses/motor coaches must be clean, orderly and in excellent condition. It may
	be equipped with Air conditioning/Non AC, sanitisation equipment, disposable
	mask and water bottle.
3	The seating capacity of the bus should be around 40-50 seats. It is expected
	that newest and highest quality buses in the contractors/individuals/Travel
	Agency fleet will be assigned to serve this contract. At the
	contractors/individuals/Travel Agency expense, drivers must have cell phones
	with them to assist in case of emergency for reaching the contacts.
4	The driver must be a responsible citizen and abide all the rules and regulations
	of transport operator. It is pertinent to note that assigned driver should be
	aware of all the routes with in the vicinity and of the city and have the
	necessary directions to drive directly to the specified destination.
5	Contractor must be accessible 24*7 per day and seven days a week to address
6	the emergency situation.
6	Extra buses and drivers will be kept available in case of breakdowns.No added
	charge shall be admissible for extra time or on equipment or drivers delays,
	instead penalty may be levied for delay in reaching the destination(details
7	below in annexure)
/	Contractor shall ensure that it's drivers have to comply with all laws and
8	regulation that pertains to safe driving and also aware of the local laws. Force Majeure cancellation: In the event of inclement weather, road blockage

	Cancellation on part of company will be intimated 24 hours in advance from the
	official time of start of journey.

	necessary to perform these contracts. All statutory documents to be submitted
14	at the time of bid submission.
14	The contractor/individuals/Travel Agency has to provide contact information of three references of companies / agencies for which they have provided services
15	during the past three years. Driver should wear mask and follow the rules & regulations of traffic and also

16	BFSL will not provide parking facility at the origination and destination point,				
	operator has to manage at their own without any cost. The official time				
	schedule for movement of bus is at 7.30 am from virar and leave Jogeshwa (west) SV road by 5.30 pm, time of journey may vary as and when required.				
	The above list is inclusive and not exhaustive i.e. scope of work shall include				
	providing professional assistance for all activities required for due compliar				
	with applicable GST Rules and provisions.
